



## Olatz Urroz to join PagoNxt as CFO

Olatz's appointment is the latest addition to the PagoNxt group's c-suite, following those of Kush Saxena from Mastercard as CEO for PagoNxt Merchant and Dean Nash from Wise as general counsel.

The announcement comes on the back of PagoNxt's solid results in the third quarter of 2022, reaching 655 million euros in revenues (+75% year-on-year in constant euros for the first nine months of 2022), with the activity growing in all markets and business units.
